- ii. a veterinarian's health certificate as to the general and repro ductive health and so undness of the Mare, including the results of a uterine culture;
- iii. worming and immunization records;
- iv. a negative Coggins test dated n o earlier than [**six** (6)] months prior to the date of this Contract.
- b. <u>Refusal</u>. This Contract is subject to acceptance of the Mare by Gypsy. If the Mare is not acceptable to Gy psy, at its sole option, Gy psy shall return the B ooking Fee to Owner and this Contract shall be void.
- 5. **Shipped Semen**. In the event that t he Mare is to be bred by shipped sem en the following term s and conditions shall apply:
- a. <u>Notice</u>. Owner shall give Gypsy seven (7) days advance notice of a request for shipment.
- b. <u>Responsibility</u>. Gy psy a ssumes responsibility only to deliver live sem en in viable condition at the time of delivery to the Owner. Owner shall arrange and pay for insem ination of the Mare and all associated veterinary costs and expenses.
- 6. **Live Cover**. In the event that the Mare is to be bred by live cover the following term s and conditions shall apply:
- a. <u>Notice</u>. Owner shall give Gy psy advance notice of shipment of the Mare to the Ranch.
- b. <u>Settling</u>. Gy psy agrees to use its best efforts to try to settle the Mare and shall have sole discretion in determining the best m ethod of breeding such m are. If, however, the Mare does not settle, Gypsy shall be held harmless.
- c. <u>Mare Health Docum ents</u>. If Owner does not present the documents specified in <u>Section 5(a)</u> to Gypsy upon the Mare 's arrival at the Ranch, Gypsy shall have a veterinarian m ake proper tests and evaluations at Owner's expense.
- d. <u>Veterinary Care</u>. Gypsy shall have complete discretion as to the necessity of veterinary examinations and care for the Mare, including, but not limited to, farrier and worming treatm ent. Gypsy

- makes no representations or warranties to Owner with respect to the Mare, its health, registration or otherwise.
- e. <u>Live Foal</u> <u>Guarantee</u>. The live foal guarantee provided hereunder is expressly contingent upon Owner properly caring for the pregnant Mare. Such proper care shall include, but is not limited to, proper feeding and nutrition, regular deworming with products approved for pregnant mares, vaccinations that are cust omary in Owner's geographical area, and proper intervention during foaling if necessary.
- 7. **Substitute Stallion**. Should the Stallion be sold, die, or become unfit for service, Owner may breed the Mare to another stallion owned by Gypsy if a greed to in a writing signed by both parties hereto.
- 8. **Risk of Loss; Insurance**. Gy psy shall not be liable for any loss, dam age, injury, death or illness of the Mare. The risk of any loss associated with the all liability occurring in conne Mare and therewith shall be the sole responsibility of Owner. It is Owner's choice and responsibility to obtain insurance c overage for the Mare. Owner shall assume all responsibility for the condition of the Mare and shall bear all risk of loss or damage to the Mare by death, disease, whatsoever whether iniurv. infection or otherwise, and by any cause what soever, including inappropriate, untim ely, or negligent insemination or failure of insem ination, and therefore shall indemnify Gypsy as provided in Section 11.
- 9. Owner's Representations and Warranties. Owner repr esents and warrants the following: (a) Owner has right and title to the Mare; (b) Owner has disclosed to Gy psy all inform ation in Owner' possession relating to the health, parentage, age, breed, dispo sition and other such attributes of the Mare; and (c) the Mar e shall be in sound bree ding condition and free from any infection or disease that may interfere with the Mare 's breeding. Owner agrees that the representations and warranties shall survive the com pletion of the transactions contemplated hereby. Owner agrees to notify Gypsy promptly in writing of any event s or circum stances that may cause the foregoing representations and warranties to be inaccurate or breached in any way.
- 10. **Term and Termination**. Either party m ay terminate this Contract at any time by giving the other party written notice of term ination (" *Termination*

- *Notice*"). Sections 10, 11 and 12 shall survive termination of this Contract.
- 11. **Indemnification**. Owner shall defend, indemnify and hold harmless Gypsy from and against any and all losses, dam ages, liabiliti es and claim s, and all fees, costs and expenses of any kind related th ereto (including, without lim itation, reasonable attorneys' fees), arising out of, base d upon or re sulting from (i) any act by or om ission of Owner or its agents or representatives relating t o or affecting the Mare, (ii) any inaccuracy or alle ged inaccuracy, asserte d by Gypsy or any third party in a court action, of representation or warranty made by Owner pursuant to this Contract; or (iii) questions of title to the Mare and disputes concerning identity , heal th, soundne ss, engagements, pregnancy status and or produce record of the Mare
- 12. **Arbitration**. Except with respect to any matters set forth herein with respect to which the part hereto m ay pursue injunctive relief in any court of competent jurisdiction, each party hereto agrees that arbitration, as conducte d b y and pursuant to the procedures set forth by JAMS (as currently in effect or such later version as m ay then be in effect) shall be the sole and exclusive method for resolving any claim, controversy or dispute arising out of or relating to the rights and obligations of the parties under this Contract, whether such claim arose or the facts on which such claim is bas ed occurred prior to or after the execution and delivery of this C ontract. Not hing in this Secti on shall prohibit any party hereto fro instituting litigation to enforce any final judgment, award or determination of the arbitration. Each p arty hereto further agrees that each other party hereto may initiate li tigation in any court of com jurisdiction to execu te any judicial judg enforcing or not enforcing any award, judgment or determination of the arbitration.

13. General Provisions

a. Entire Agre ement, Bind ing Effect. This Contract contains the entire a greement and understanding between the parties and it supersedes all prior or agreem ents, understandings, and representations, written or oral, relating to the subject matter of this Contract. This Contract shall be binding upon the parties and their representatives, succe ssors, and assigns.

- b. Waiver of Jury Trial. Each party hereto hereby waives its rights to a jury trial of any claim or cause of action based u pon or arising out of this Contract. The scope of this waiver is intended to be all-encompassing of any and all disputes that may be filed in any court and that relate to the subject matter of this transaction, in cluding, without limitation, contract claims, tort claims, breach of duty claims, and all other common law and statutory claims.
- c. Governing Law; Venue. This Contract shall be construed in accordance with and governed by the laws of the State of Texas, without giving effect to the choice of law provisions thereof. Buy er agrees that any lawsuit or other legal proceeding between the parties shall be brought only in the Civil District Courts of Harris County, Texas or the United States District Court for the South ern District of Texas, Houston Division. The parties hereby consent to the personal and exclusive jurisdiction and venue of said court.
- d. <u>Costs of Dispute</u>. In the event a dispute arises under this Contract, the prevailing party will be entitled to all reasonable costs and expenses incurred by it in connection with such dispute (including, without limitation, all reasonable attorney's fees and costs incurred before and at any trial, arbitration or other proceeding), as well as all other relief granted in any suit or other proceeding.
- e. <u>No Rights in Third Parties</u>. U nless otherwise ex pressly stated herein, this Contract shall not create any rights in or inure to the benefit of any third parties.
- f. Notices. An y notice required or perm itted to be given under this Contract shall be in writing and shall either be perso nally delivered or sent postage prepaid, by certified mail, regular mail, personal delivery, courier service, facsimally items indicated below or email, to the address of the parties indicated below or to such other address as either party shall designate by notice to the other party. Such notice shall be effective when actually received or two days after deposit in the U.S. Postal Service, whichever occurs first.

This Contract may be executed in a number of identical counterparts and each of such shall be deemed for all purposes to be an original, all of which shall constitute, collectively, this Contract. k. Section Headings. The section headings designations used in this Contract are for convenience of reference only, and shall not in any way be construed to modify or restrict any of the terms or provisions hereof. |
